Record of Proceedings

The present Petitions have been filed for true-up of the transmission tariff for the 2019-24 period and for the determination of the transmission tariff for the 2024-29 period. During the course of the hearing, the following specific submissions were made by the Petitioner's representative in these petitions:

In Petition No. 189/TT/2025

2. The Petitioner's representative submitted that the present Petition needs to be amended in view of the Commission's order dated 25.10.2024 in Petition No. 94/TT/2024, wherein it was observed that works, including re-conductoring, shall be claimed as part of the Additional Capitalisation under the original project. In line with the Commission's said observation, the Petitioner has to include the re-conductoring work of Asset-1(i), i.e., LIL0 of both circuits of 400 kV D/C Rourkela - Raigrah (2nd line) along with 4 Nos 400 kV line bays at Jharsuguda (Sundargarh) GIS in this Petition, and, as such, an amendment is being sought.

In Petition No. 378/TT/2025

3. The Petitioner's representative submitted that the present Petition needs to be amended to include the claim of the Additional Capitalisation and the corresponding de-capitalisation on the grounds of the upgradation of the SCADA system at Ballia and Bhiwadi HDVC stations.

4. After the hearing, the Commission allowed the Petitioner's request for amendment of the Petitions, subject to just exceptions and directed as under:

- a) The Petitioner to appropriately amend the Petitions within two weeks, with an advance copy to the Respondents;
- b) Notice of the amended Petitions be issued to the Respondents;



- c) The Respondents to file their respective replies to the amended Petition, if any, within two weeks after the receipt of a copy of the amended Petitions, with an advance copy to the Petitioner, who may file its rejoinder, if any, within a week thereafter.

5. These Petitions will be listed for hearing on **21.10.2025**.
