### **Record of Proceedings**

The representatives of the Petitioner have submitted that these Petitions have been filed for the truing up of the Transmission Tariff for the 2019-24 and/or the determination of the Transmission Tariff for the 2024-29 tariff period.

2. It was further submitted that the Respondent, MPPMCL, in Petition No. 268/TT/2025 and the Respondents, MPPMCL & CSPDCL, in Petition No. 269/TT/2025, have filed their reply and the Petitioner has filed rejoinder in Petition No. 269/TT/2025. However, none was present on behalf of the Respondents despite notice.

3. The Commission directed to list the matters before the Coram of two Members, namely Member (Technical) and Member (Legal).

4. After hearing the Petitioner's representatives, the Commission directed as under:

- a) Issue notice again to the Respondents;

- b) Form-9C for the transmission assets in linked Excel format.
