## **Record of Proceedings**

The present Petitions have been filed for the determination of the transmission tariff from the COD to 31.3.2024. During the course of the hearing, the Petitioner's representatives briefed about their Petitions and requested that the transmission tariff be allowed as claimed in the respective Petitions.

2. The Petitioner's representative in Petition No. 373/TT/2024 sought some more time to file the details of the Revised Cost Estimate (RCE).

3. After the hearing, the Commission directed the Petitioner to submit the following information in the following Petitions, on an affidavit, within a week:

### **In Petition No.214/TT/2024**

- (i) Detailed justifications for the delay from SCOD to COD for the transmission asset.
- (ii) Tariff Form-9C for the transmission asset in linked Excel format.
- (iii) Form-12 for the transmission asset.

### **In Petition No.300/TT/2024**

- i) Detailed justifications for the delay beyond SCOD to actual COD for the transmission assets.
- ii) Tariff Form-9C for the transmission assets in linked Excel format.
- iii) Form-12 for the transmission assets.
- iv) Liability Flow Statement for the transmission assets, if any, in Excel format.

### **In Petition No. 373/TT/2024**

- i) RCE details.
- ii) Notional IDC calculation in Excel along with the revised Auditor's Certificates.
- iii) Tariff Forms-9C and 12 for the transmission assets in linked Excel format.

### **In Petition No. 390/TT/2024**

- i) SCOD mentioned in Form-4C for the transmission assets in Tariff Forms differs from the Petition. Rectify the same.
- ii) Tariff Forms 9C and 12 for the transmission assets in linked Excel format.



**In Petition No. 501/TT/2024**

- i) Revised Auditor's Certificate including notional IDC details.
- ii) Activity-wise delay with proper reasons along with Tariff Form-12.
- iii) Linked Excel of all the loan sources mentioned in Tariff Form-9C.

**In Petition No. 266/TT/2025**

- i) The justifications for the delay provided by the Petitioner pertain to the period after the SCOD. Provide the reasons for the delay in the execution of work till SCOD.
- ii) Tariff Form-12, along with proper justifications.
- iii) Revised Auditor's Certificate, including the details of notional IDC.

4. The Commission also directed the Respondents to file their respective replies, if not already filed, within a week, with a copy to the Petitioner, who may file a rejoinder, if any, within a week thereafter.

5. Subject to the above, the Commission reserved the order in the matters.
