3. The Commission further directed the Petitioner to file the following information on an affidavit within two weeks:

(a) The list of elements for which unrecovered depreciation is claimed under the instant Petition, along with the total unrecovered depreciation amount after adjusting salvage value or realisation value, if any, with relevant supporting documents.

(b) The approval for decommissioning or replacement of such elements accorded by CTUIL, CEA or in any RPC or other meetings, as the case may be, for each of the element.
